

Subject: Privacy Policy Statement pursuant to Art. 13 Lgs. Decree 196/2003 (“Data Protection Act”)

This Privacy Policy is for those who consults and / or interacts with the services provided by Sestriere Vernici srl available on the domain and sub-domains related to the website www.sestrierevernici.com.

By visiting this website, therefore, you accept the terms and conditions of this Privacy Policy.

In case of refusal, you are requested not to access to the services offered by Sestriere Vernici srl web and do not use them.

Lgs. Decree 196 of 30 June 2003 – Data Protection Act – serves to guarantee that personal data will be processed correctly, lawfully and with transparency, respecting the rights, fundamental freedoms and dignity of the data subject, particularly with regard to confidentiality, personal identity and the right to personal data protection.

In compliance with the Lgs. Decree 196 , we therefore inform you that your personal data, provided to Sestriere Vernici S.r.l. or any data of which Sestriere Vernici S.r.l. becomes aware during the relationship or dependent on same (as communicated by you or pertaining to relevant subjective or objective situations for the purpose of the relationship), will be processed by Sestriere Vernici S.r.l. in its capacity as data controller for the following purposes of management of company actions and specifically:

- to send promotional material;
- a statistical analysis for business purposes;
- records.

Processing will be carried out by Sestriere Vernici S.r.l. using hard copy and/or electronic means, connected via private and public networks, in compliance with this Privacy Policy.

Sestriere Vernici srl is committed to respect and protect your privacy using your personal data in accordance with the legal provisions aimed at ensuring the safety, accuracy, updating and relevance of the information provided in connection with the declared purposes. The provision of data is obligatory for anything pursuant to the performance of contract and as required by law. Any refusal to provide data may lead to failure to continue the relationship without responsibility for the Sestriere Vernici. S.r.l. company. Provision of data is optional for other purposes.

Data may be communicated to the following people or entities:

- Sestriere Venici S.r.l. members of the data controller’s network, including dealers, distributors, agents and marketing assistants; to the extent strictly necessary and to the purposes set out in this Notice and / or services requested by you.
- public administrations for fulfilment of obligations envisaged by law, regulations or EU standards (e.g. Local Health Authorities, Employment offices, Tax and Finance Administration);

Data provided may come to the notice of data processors appointed by Sestriere Vernici S.r.l., within and outside the company.

The data controller, pursuant to Art. 4, I comma, letter f) and 28, I comma, second part, Lgs. D. 196/2003, is Sestriere Vernici S.r.l., in Nichelino (TO) street Quarto 11 (P.IVA 00481120012) , in the person of the current legal representative, at the headquarters of the Company.

Data subjects may exercise the right as stated in Art. 7 Lgs. D. 196/2003 by contacting the data controller.

The data subject may in respect of Your rights

Art. 7 (The right to access personal data and other rights)

1. The party concerned has the right to obtain confirmation of whether personal data concerning him/her exists or not, even if not yet registered, and to receive this data in an intelligible form.
2. The party concerned is entitled to obtain information regarding:

- a) the origin of their personal data;
- b) data processing purposes and methods;
- c) the logic applied in the case of data processed with the aid of electronic tools;
- d) details identifying the data controller, data processors, and the designated representative in accordance with Article 5 paragraph 2;
- e) the persons or types of persons personal data could be sent to or who may have access to such data in their role as the designated local representative in the country, as controllers or employees.

3) The party concerned is entitled to obtain:

- a) updates, amendments or, where relevant, supplements to their data;
- b) the deletion, conversion into anonymous form, or blocking of data processed unlawfully, including data whose storage is not necessary for the purposes for which the data was gathered or subsequently processed;
- c) confirmation that the actions listed at letters a and b have been brought to the attention (also as regards their content) of the persons with whom the data was shared or disclosed, except in the event that this action proves impossible or requires the use of means that are clearly disproportionate to the rights protected.

4) You have the right to object, in whole or in part:

- a) for legitimate reasons related to the processing of personal data, pertinent for collection purposes;
- b) to the processing of personal data for purposes of sending advertising materials or direct selling or for carrying out market research or commercial communication.
